

City Planning Updates - January 2023

Citywide

Draft Permanent AI Fresco Ordinance (<u>CF 20-1074</u>**):** A proposed ordinance to update and expand outdoor dining provisions within the Zoning Code. The proposed ordinance will provide for a transition from the current, temporary LA AI Fresco expanded outdoor dining program to a permanent program on private property.

Wildlife Pilot Study (CF 14-0518): A proposed ordinance to amend the Los Angeles Municipal Code (LAMC) and create a Wildlife Ordinance District that establishes regulations restricting location, size, fencing, landscaping and design requirements of new development within the Wildlife Ordinance District.

- To be considered by City Council in Early 2023
- Approved by the City Planning Commission (CPC) on 12/8/22
- Pending consideration by the Planning and Land Use Management Committee

Regional

South LA CPIO Amendment (CF 20-1265-S1): Proposed amendments would create a new administrative process to review projects within a new "CPIO Protected Unit Area" whereby residential projects would be subject to existing CPIO Residential Subarea development standards. New, additional provisions would require the replacement of affordable housing and delay demolitions.

Los Angeles City Planning December 2022 Recap

Proposed Oil and Gas Drilling Ordinance (CF 17-0447-S2): This new

ordinance prohibits new oil and gas extraction, makes existing extraction activities a nonconforming use in all zones, and requires phasing out of existing operations after an amortization period.

- Approved by the Planning and Land Use Committee (PLUM) on 11/1/22
- Adopted by the City Council on 12/2/22
- Ordinance effective on 1/18/23

Process and Procedures Ordinance (CF 12-0460-S4): The Ordinance streamlines case processing and reorganizes the rules that govern the steps involved in reviewing projects or adopting land use policy, while introducing a more user-friendly format with flowcharts and visual aids. It reduces over 120 different types of planning entitlements in the current Zoning Code down to about 60 unique review paths. It makes the rules for how the Department reviews land use and development applications more consistent and accessible.

Westside Community Plans Update:

- Westside Community Plans Advisory Group (WCPAG) Update

 - Advisory Group will assist planning staff in evaluation land use policy and zoning throughout the Community Plan Update Process

Harbor LA Community Plan Update Outreach Events

- In Fall 2020, the Harbor LA team released a <u>StoryMap</u> that shows the proposed land use designations and zoning metrics for the Harbor Gateway, Wilmington, and Harbor City communities
- Since then, the StoryMap was updated based on community feedback and also includes information on the new zoning code's Frontage District and Use District Categories
